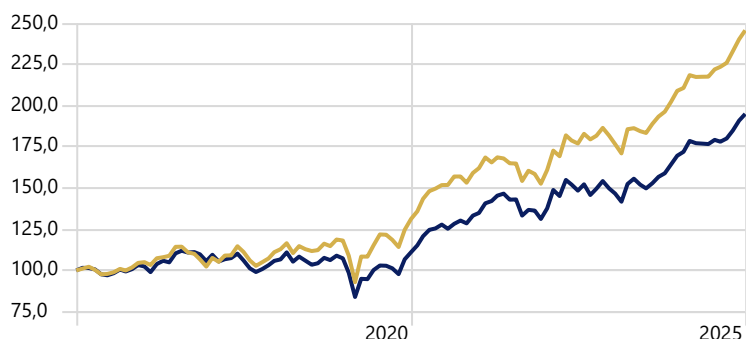


## INVESTMENT OBJECTIVE:

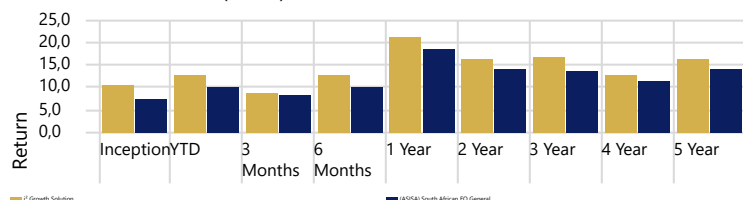

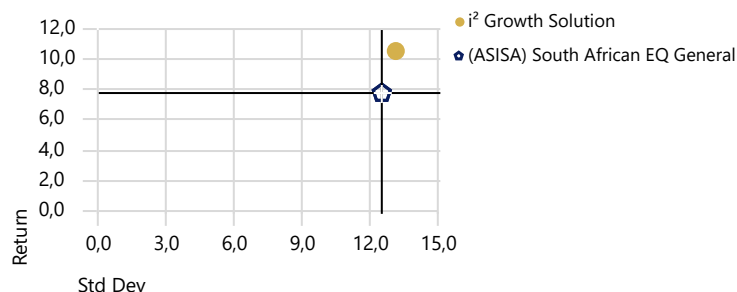

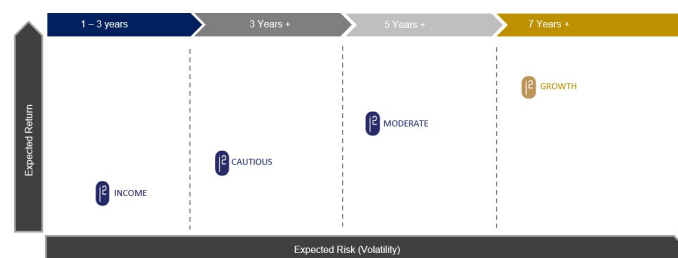

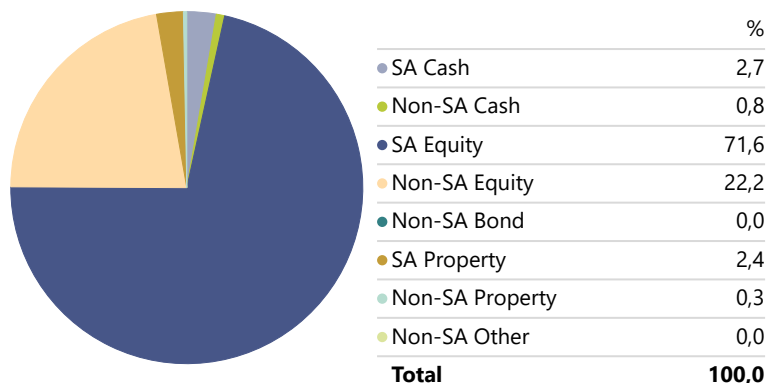

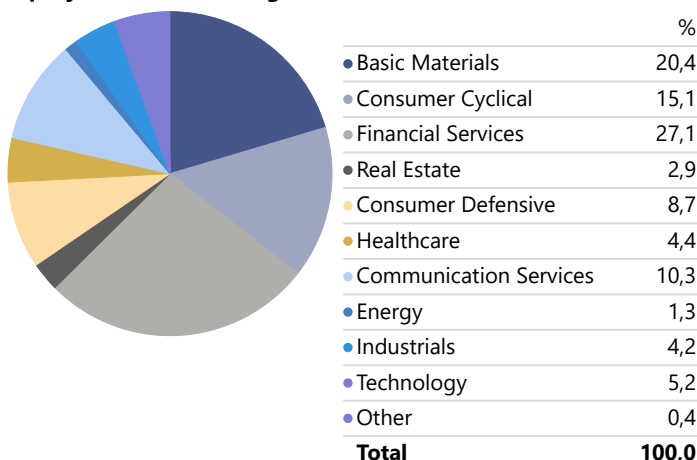
