



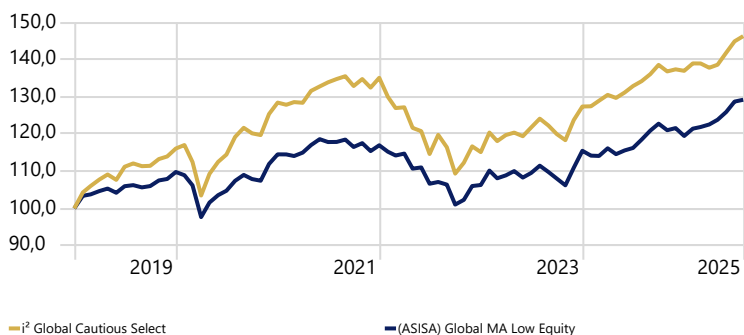

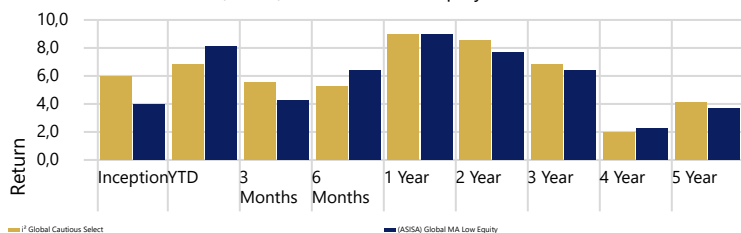
Investment Growth - USD

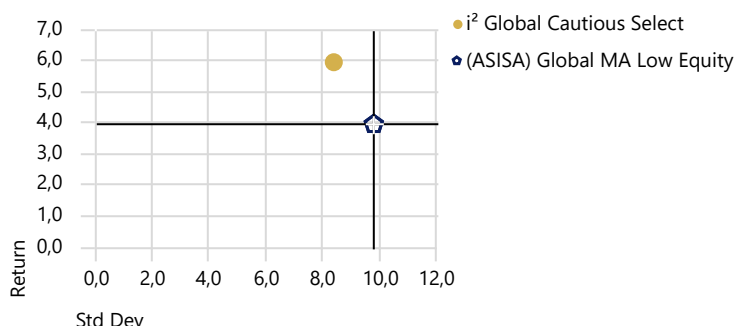

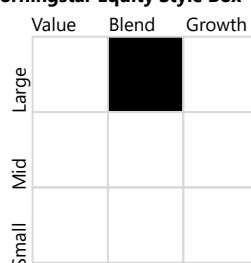

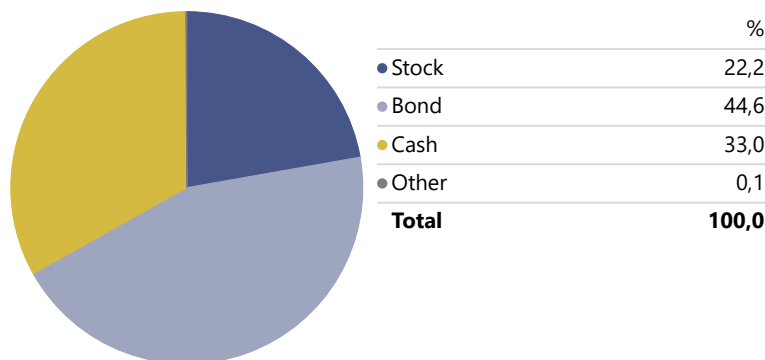

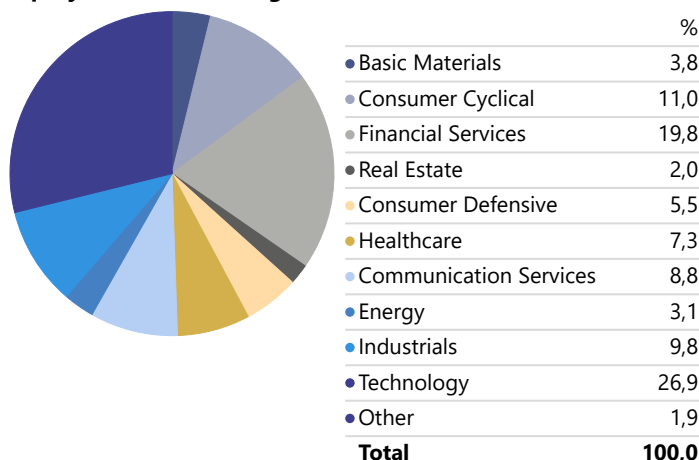
