




FTSE/JSE Industrial 25
















SA CPI


South Africa - Business Confidence Index


SA Retail Sales MoM Growth (%)


5 vs 10 vs 30 Year Yields


Market Volatility Index (VIX)


Eurozone – Consumer Confidence


5 vs 10 vs 20 vs 30 Year Yields














