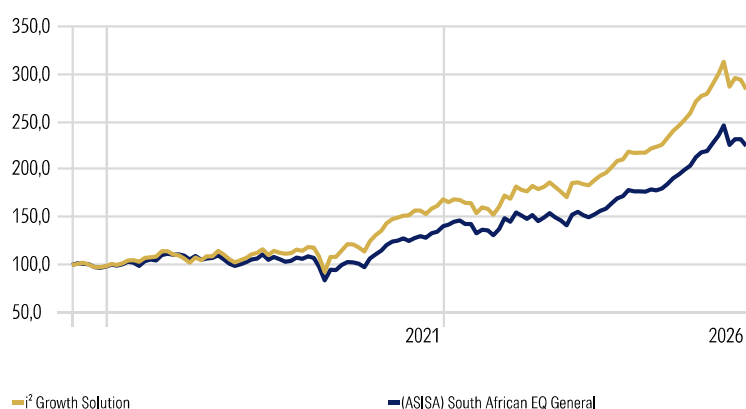


INVESTMENT OBJECTIVE:

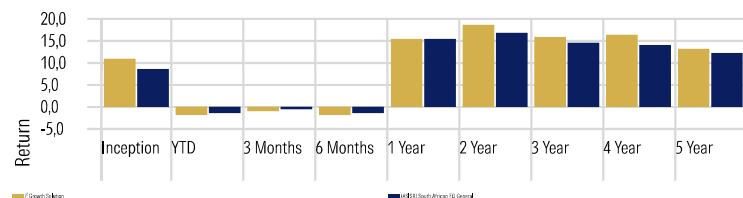
Investment Growth

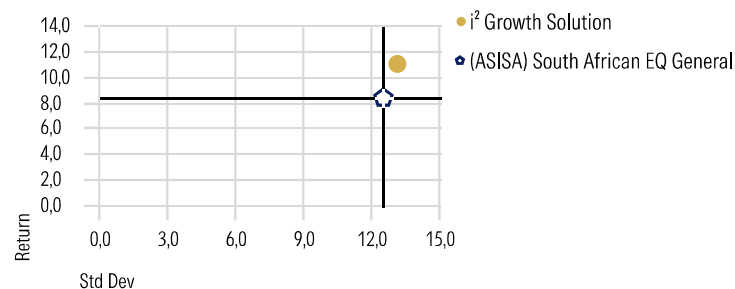

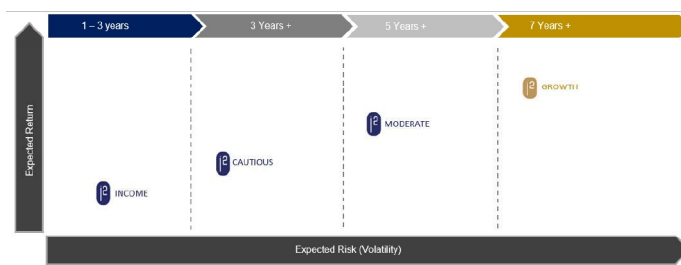

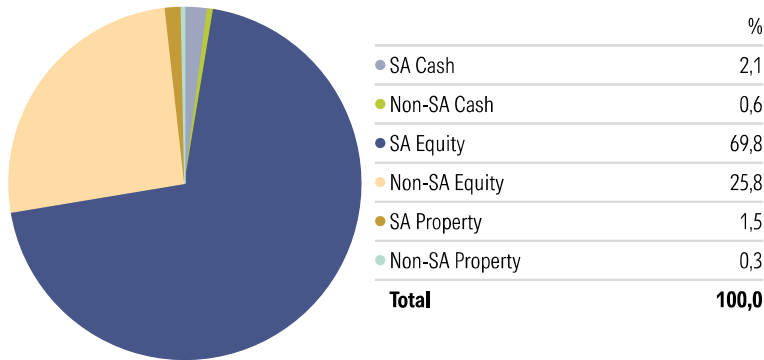

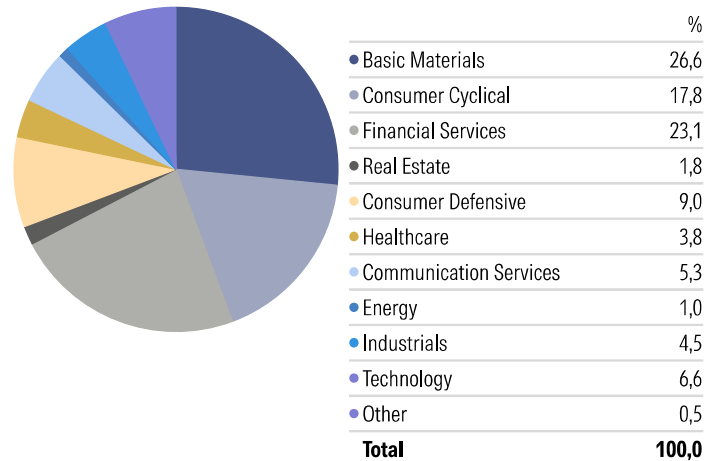
